In Memory of The Honourable David F Jackson AM KC























The Honourable David Francis Jackson AM KC, a prominent figure in the Australian legal community, passed away on 15 May 2023. His death was met with public announcements and commemorations from various legal associations, emphasising the significant impact he had on the legal profession. A memorial mass was held in his honour at St Mary's Cathedral in Sydney, with the eulogy delivered by Chief Justice Susan Kiefel AC of the High Court of Australia, creating an atmosphere akin to a state funeral.

Born on 8 May 1941 in Ipswich, Mr Jackson's family moved to Brisbane after the untimely death of his father when he was still a child. He attended Marist College Ashgrove, where he excelled academically. Mr Jackson graduated from The University of Queensland with a Bachelor of Arts in 1963 and Bachelor of Laws in 1964, earning recognition for his achievements, including the Ross Anderson Memorial Prize for constitutional law.

In addition to his academic pursuits, Mr Jackson served in the Reserves of the Australian Intelligence Corps between 1959 and 1971 and retired with the rank of Major. His military career was hindered by eyesight issues, which led him to embark on a legal path. On 29 May 1970, he married Monica Letheren.

In 1963, Mr Jackson worked as an Associate to The Honourable Sir Harry Gibbs, then a Judge of the Supreme Court of Queensland, who later became the Chief Justice of the High Court of Australia. These years working with Justice Gibbs left a lasting impression on him, not only because of his role in the National Hotel Inquiry, but also because of the influence Sir Gibbs had on his life.

In 1964, Mr Jackson started his legal practice at the bar in Brisbane. During his early career, he often appeared alongside other legal luminaries, including Charlie Sheahan QC, in constitutional litigation cases during the Whitlam government.



He was appointed as a silk at the Brisbane Bar from 1976 to 1985 and served in various roles within the Bar Association of Oueensland.

In 1985, Mr Jackson was appointed as a Justice of the Federal Court of Australia, based in Sydney. He held this position until 1987 when he returned to practising as a barrister in Sydney. During this time, he developed an exceptional appellate practice. He led the Seventh Floor of Wentworth Chambers from 2002 to 2014 and

co-founded and led New Chambers from 2014 to 2016, where he remained until his passing.

In recognition of his contributions, Mr Jackson was made a Member of the Order of Australia in 2007 for his service to the legal profession. However, his true legacy his court craft. He was considered one of Australia's finest constitutional and High Court barristers, appearing in numerous cases across various legal areas.

Chief Justice Bell once described him as, "In truth a generalist. His speciality was advocacy, the art of persuasion. His skill as an appellate advocate was universally admired and to work with him was an education to any junior counsel in the importance of meticulous preparation, the logical and coherent structuring of submissions and anticipating questions from the Bench. His standards were exacting, his courtesy exemplary and his personality warm and generous."

Mr Jackson's impact on the legal community in Queensland was substantial, nurturing multiple generations of legal leaders. Beyond his legal career, he was known for his generosity and commitment to pro bono work; maintaining his dedication to the Order of Malta and demonstrating a true sense of giving without seeking recognition.

Mr Jackson's legacy is one of excellence, integrity and generosity. He has left an indelible mark on the Australian legal landscape, serving as a role model and mentor to generations of lawyers. Peter Dunning KC described Mr Jackson as, "The barrister the rest of us measure ourselves by. He was a legend in his own lifetime."

Like most years, each team worked extremely hard to master their moot problem and craft intelligent arguments to present through exceptional advocacy skills on competition day. However, unlike in recent years, most of our teams were finally lucky enough to have travelled this year for their respective competitions in Canberra, Melbourne, Sydney, Washington DC, London, Swansea, Vienna and The Haque.

Thank you to all for joining us this evening to pay a special tribute to the legacy of The Honourable David Jackson AM KC and to celebrate the impressive achievements of our mooting teams in 2023.

Guest speaker

The Honourable Glen Norman Williams AO is a graduate of the UQ Law School and has had a remarkable career as a leading Queensland barrister, judge and law reformer, while also contributing to the life and work of the Law School for over 60 years.

Mr Williams was born in Brisbane in 1938. He was educated at St Joseph's College, Gregory Terrace (1952–55), and won a Commonwealth Scholarship to The University of Queensland. In 1959, he graduated from with a Bachelor of Arts in Political Science with First Class Honours. His thesis was on special tribunals. A few years later in 1962, he graduated with a Bachelor of Laws, achieving First Class Honours, and won the Henderson Prize in Law.

In 1962, Mr Williams served as an Associate to The Honourable Sir Harry Gibbs, then a Judge of the Supreme Court of Queensland, who later became Chief Justice of the High Court of Australia. On 8 April 1962, Mr Williams was admitted as a barrister of the Supreme Court and, after completing his Associateship, commenced practice at the Queensland Bar. He also commenced a long period of service as a part-time lecturer at the Law School in Family Law (1964–67) and Civil Procedure (1971–78). While at the Bar, Mr Williams was a committee member of the Bar Association of Queensland (1964–66) and commenced a long period of service as a member of the Queensland Law Reform Commission (1976–89). Mr Williams was appointed Queen's Counsel in 1978.

On 7 April 1982, Mr Williams was appointed an Acting Judge of the Supreme Court of Queensland. A permanent appointment to the Court followed on 3 December 1982. He also served as a Judge of the Court of Appeal of the Solomon Islands (from 1993) and President of the Industrial Court of Queensland (1998–99). On 14 December 2000, he was appointed a Judge of the Queensland Court of Appeal.

Mr Williams was awarded the Centenary Medal in 2001 and appointed an Officer of the Order of Australia in 2006. He served as Chair of the Queensland Law Reform Commission (1993–96), as a member of the Council (1985–88), and later as Chair of the Australian Institute of Judicial Administration (1988–90), Vice Chair (1996–2000), and Chairperson (2000–04) of the International Bar Association Judges Forum. He also served as Chairperson of the Supreme Court rules committee (1999–2007), President of The University of Queensland Law Graduates Association (from 1999), and director of the Expert Witness Institute of Australia (2000–07).

Mr Williams was awarded a Doctor of Laws honoris causa by The University of Queensland in 2003.. He retired from the Court, at the age of 70, on 24 January 2008. He was then appointed an Adjunct Professor at the TC Beirne School of Law at The University of Queensland (2008).

We are fortunate to have The Honourable Glen Williams AO — a close, life-long friend of David — here tonight to serve as our guest speaker and pay tribute to his friend and fellow traveller in the law. Members of David's family are also in attendance to present the David F Jackson Trophy for Outstanding Advocacy.

I look forward to celebrating the success of all those for whom The David F Jackson Mooting Dinner was established. I sense that this year's event will be extra special.


