



An uplifted atoll



Island and People of Rennell

86km long and 15km wide

250km south of Honiara

Rennell is the largest raised atoll in the world

Lake Tengano at 15,000ha is the largest lake in the insular Pacific

Polynesian outlier populated from New Caledonia region

Population ca 2000

Provincial capital: Tigoa (popn 170)

Religion: SSEC in the east and SDA in the west

Medical: 2 basic clinics

Industry: logging and mining (bauxite)

Subsistence: gardens, Lake Tengano fish (tilapia and eels), marine fish and shellfish

Munch-Petersen N.F. (2011) An Island Saved *in* Island Futures. Global Environmental Studies.

Food from gardens and fishing, supplemented by hunting and collecting.

Yams, taro, tannia and sweet potatoes and coconut important for nutrients and raw material.

Women cook and garden, fishing inshore (on the narrow reef), plaiting, making nets, and caring for young children.

Men do the heavy gardening, catch coconut crabs, fish, make cordage, and are responsible for canoe making and house building.

- Vulnerable









Pacific Pollution Plan (PACPLAN)

A SPREP (South Pacific Regional Environment Plan) with the AIM to prevent/minimise damage to marine and coastal environments and resources from marine spills, and to provide systems, frameworks and guidelines to assist with response and recovery of the environment and resources damaged by marine spills in the Pacific islands region.








Pacific Pollution Plan (PACPLAN)

- Plan to foster cooperation, training, detection and reporting of oil spills
- Outlines the mechanism and procedures by which SPREP island members (Solomon Islands) may request assistance from each other, from SPREP metropolitan members (Australia) or from industry (assistance from Australia)
- Facilitate actions and cooperation consistent with the Noumea Pollution Protocol 1986, the OPRC Convention and the OPRC-HNS Protocol at the operational level by all SPREP members (in context of existing international law)
- Provides guidance for the recovery of costs of responding to marine spills (with provisions for cost recovery by those providing assistance)

Bunker Convention 2001

Three core principles

- 1. Strict (but limited) liability of ship-owner
- 2. Compulsory insurance
- 3. Direct action against insurer



Bunker Convention 2001

What could have been application to MV Solomon Trader

- 1. No need to prove negligence or some other basis for liability
- 2. Compulsory insurance (exists in form of P&I club Korea P and I club)
- 3. Direct action against insurer (action taken directly against P&I club (Korea P and I) rather than shipowner (South Express/King Trader)

Bauxite and Rennell

Asia Pacific Investment Development (APID) a logging company Bintan Mining (Indonesia) operates the bauxite (karst bauxite) mine for APID Solomon Trader was picking up a load of bauxite when it grounded Chief Joshua Na'siu is the chief of Aba'tai (Abatai) village: "...allowed the company to dig up his gardens to mine for bauxite" (Radio New Zealand, 13 May, 2019)



Causes and effects

Causes

- Corrupt progression from logging to mining
- Poor infrastructure
- About 300 tonnes bunker oil, diesel, spread some 600 kilometres away
- Bauxite was dumped from 2 barges into the bay to protect them from the cyclone

Effects

- Bauxite has contributed to the odious smell, killing fish and marine life
- Loss of gardens
- Loss of forest
- Loss of graves and cultural icons
- Contamination of the aquifer
- Damage to corals, fish and invertebrates




