

Class allocation - Semester 1, 2020

All students are required to register their preferred times through My Timetable where there is a choice of classes.

The class preferencing window opens about 4 weeks before the semester begins and closes about a week later – check the Academic Calendar for the exact dates. During this time, you'll need to select your preferred class times for each of your courses.

Note: If a course is not listed below it means there is no choice of class, and therefore no requirement to register your preference.
