



2020 International Legal Studies Externship Clinic

Chiang Mai, Thailand

Monday 6 July to Friday 24 July 2020

What is the International Legal Studies Externship?

The International Legal Studies Externship Clinic in Chiang Mai is a three-week in-country student placement experience for academic credit. Students will gain international experience working alongside lawyers and law reform advocates in a social justice setting in Chiang Mai, Thailand. The UQ Law School and the School of Humanities and Social Sciences is partnering with BABSEACLE (*Bridges Across Borders South-East Asia Clinical Legal Education*) to send students to work and study in Chiang Mai in July 2020.

Students will make a real contribution to helping people achieve access to justice whilst being involved in a remarkable experience of living and working in Asia. Students will contribute in many ways including:

- Research on thematic areas including women's rights, indigenous rights, rights of drug users, migrant worker rights, disability rights and environmental justice;
- Supporting the development of access to justice and pro bono initiatives across Asia, most notably the Asia Pro Bono Conference and the Asia Access to Justice Week;
- Access to justice roundtable support and network building.

Application process

HASS students are invited to apply as part of PHSS2000 (Practical Employability Experience).

The three-week clinic will start on Monday 6 July and will finish on Friday 24 July. The timeframe aligns with the University mid-semester recess.

The application process is as follows:

1. Complete the **attached** BABSEACLE Legal Studies International Externship Clinic Application Form. Applications close **Sunday 22 March 2019 at 5pm (BNE time)**. Applications and materials must be submitted by email to chiangmai.team@babseacle.org and probono@law.uq.edu.au.
2. The School of Law, HASS and BABSEACLE will shortlist candidates. All applicants will be advised whether or not they have been shortlisted by **Wed 25 March 2020**.
3. Shortlisted candidates will attend a pre-selection Zoom interview with the BABSEACLE team in the **week starting Monday 30 March 2020**. Final offers will be made to the successful candidates in that same week.

Clinic Costs

The cost per student for the 2020 International Legal Studies Externship Clinic is **\$1,950 USD** (internal transportation, work permit and accommodation costs). This cost includes:

- Volunteer visa paperwork
- Workplace permissions and approvals
- In-country transportation related to all externship activities

- BABSEACLE planned cultural & wellness activities
- All training and work-related training materials
- Legal supervision and mentorship
- Administration & coordination costs
- A local country support team
- Twin share accommodation while on placement
- Support for our Community Legal Education partner programs

It does not include flights or visas. UQ Law School has New Colombo Plan funding to support this clinic. Each successful eligible student will receive **\$3000 AUD** towards their travel and living costs.

PLEASE NOTE: UQ OS-HELP loan deadline for overseas study in this period is **15 March**. OS-Help loan applications can be withdrawn without penalty if your application is unsuccessful so it is best to apply at the outset.

UQ will arrange a full pre-departure risk assessment for selected students. As an official elective LAWS course, UQ travel, personal accident, professional indemnity and public liability insurance will cover students on placement. Please read the insurance material carefully to ensure you are comfortable with the level of cover, some students prefer to arrange additional cover privately.

PHSS2000 and further contacts

PHSS2000 is a graded course. Formal assessment will include a work plan, reflective journals, participation and a 'me-in-a-minute video' related to the clinical work engaged in with BABSEACLE.
