### THE HONOURABLE JUSTICE SORAYA RYAN

The Hon Justice Soraya Ryan is a graduate of The University of Queensland—Bachelor of Commerce and Bachelor of Laws (First Class Honours). Her Honour was awarded prizes in Criminal Law, Mining Law and Evidence.

Justice Ryan was admitted as a barrister in 1991. From 1992 to 2009 her Honour worked as a prosecutor at the Office of the Director of Public Prosecutions, a lecturer in Evidence at The University of Queensland and as in-house defence counsel at Legal Aid Queensland. In 2010, her Honour commenced practice at the private bar, specialising in criminal law. Justice Ryan was appointed Queen's Counsel in 2013.

As a barrister her Honour served as a member of the South Pacific Region Education Committee and the Bar Practice Course Management Committee. Justice Ryan has further served as an Executive Consultant at the Queensland Law Reform Commission (QLRC) and as a part-time Commissioner at the QLRC. Since 1996 her Honour has been an author of Carter's Criminal Law of Queensland.

Justice Ryan was appointed a judge of the Supreme Court of Queensland on 9 March 2018.



# SPECIAL THANKS DAVID F JACKSON AM QC

The annual mooting dinner is named in honour of our esteemed alumnus David F Jackson AM QC.

Mr Jackson graduated from UQ with a Bachelor of Arts (1963) and Bachelor of Laws in 1964, during which time he worked as Associate to The Hon Sir Harry Gibbs, then a Judge of the Supreme Court of Queensland who later became Chief Justice of the High Court of Australia. He was awarded the University's Ross Anderson Prize in Constitutional Law in 1963, and the Virgil Power, Henderson and Wilkinson Prizes in 1964. He was called to the Bar in 1964, appointed Queen's Counsel in 1976 and was in private practice in Brisbane until 1985 when he was appointed a Judge of the Federal Court of Australia in Sydney. He left the Court in 1987 and since then has practised at the Bar from Sydney.

Mr Jackson is regarded as one of the nation's most distinguished barristers. His principal areas of practice are: appellate; constitutional law; arbitration; and mediation. He was Head of Chambers at Seven Wentworth (one of Australia's most respected barristers' chambers) from 2002-2014, and the first Head of New Chambers from October 2014 to May 2016.

Mr Jackson has conducted a number of inquiries for national and state governments.

Mr Jackson has appeared in hundreds of matters in the High Court of Australia, in both its original and appellate jurisdiction, and in numerous matters in the federal and state intermediate appeal courts.

He has published frequently and delivered many papers.

The 2018 Jessup problem took the team to the Odasarra region, a geopolitical powder keg modelled off the likes of North Korea. China. Japan. South Korea and the United States. The team was introduced to a challenging mix of topical issues, including nuclear disarmament, naval warfare and inter-state arbitration. Over the summer the team became experts in interpreting vaguely-worded security council resolutions. whether an autonomous underwater vehicle is a "ship"



and how many nutritious meals can be cooked on a sandwich press. Having mastered these essential mooting skills the team travelled to Canberra for the Australian qualifying rounds. At the International Rounds, UQ competed in an exhilarating Grand Final against India judged by Judges Abraham, Sebutinde and Gevorgian of the International Court of Justice, taking home the title of "World Champions".

In February 2018, UQ took part in the lan Fletcher International Insolvency Law Moot Competition in Vancouver. This was the Moot's second year and UQ's first entry into the competition. The hypothetical problem for 2018 centred on the application of the UNCITRAL Model Law on Cross-Border Insolvency to a dispute concerning a large corporation with assets and creditors in multiple States. Despite some initial challenges



building familiarity with this relatively new and niche area of law — there being almost no guiding commentary yet available, and the courts of different countries having unhelpfully tended to assume conflicting positions — the team was ultimately able to achieve a comprehensive and intuitive understanding of the material. After performing well in the written qualifying round, UQ advanced to the oral rounds in Canada and there met with success in the four preliminary moots and in the semi-final. The team was pleased to progress through to the Grand Final before an eminent panel of judges, but unfortunately went down to the hosts, University of British Columbia, in a tight contest.

The Fletcher Moot was nonetheless an excellent learning experience, offering the team the unique opportunity to explore an area of law still in its infancy and to interact closely with the judges, lawyers and academics actually responsible for its creation and development. As cross-border expansion becomes an increasingly popular strategic decision for modern corporations, the concepts considered in the course of the Moot are sure to be of great commercial relevance.

In March, the 2018 Willem C Vis International Commercial Arbitration Moot represented The University of Queensland in Vienna. The Moot was attended by 367 law schools and over 1000 academics and practitioners who acted as arbitrators. This year, the problem concerned the modification of rules of arbitral procedure. the challenge of an arbitrator, the incorporation of standard terms, supply chain liability, and the conformity of goods with ethical standards. Before competing in Vienna, the team competed in two 'premoots', run by CIArb Australia and the Austrian firm Vavrovsky Heine Marth. They won both. At the conclusion of the general rounds, the team was ranked 10th, and so broke into the final rounds. There, the team was defeated by the Honourable Society of Middle Temple in a closely contested moot.



The Moot was an invaluable and highly rewarding experience, as were the two weeks the team spent in Italy afterwards thanks to the Commonwealth Games extending the Easter break.

In August, UQ was represented at the 4th annual Aboriginal and Torres Strait Islander Students' Moot, held at the Federal Court building in Brisbane. This year, the problem involved a dispute between partners to a joint venture in Far North Queensland that involved a range of issues from contractual interpretation to negligence. Extra credit must be given to Cassia, who entered this competition in her first year of law school and performed very well. In the end, the hard work paid off and the team was able to defeat Bond University in the final, in front of an all-star panel consisting of Chief Justice James Allsop of the Federal Court, Justice James Edelman of the High Court and President Walter Sofronoff of the Queensland Court of Appeal. It was a great victory, but more importantly the team learned a great deal about modern advocacy with workshops and sessions with senior barristers giving invaluable advice. The competition as a whole was an incredible experience, and certainly one that any aspiring indigenous law student should definitely consider signing up for.

Eleven teams from across Australia and Fiji came to compete in the four day event at QUT. The moot problem concerned a doctor misdiagnosing a lymphoma. The plaintiff alleged that the delay caused by this misdiagnosis resulted in an upstaging of the cancer and an increase in negative prognostic factors. The problem raised issues of causation, the peer professional defence under section twenty two of the Civil Liability Act and contributory negligence. The quality of the competition was very high and the team relished the opportunity to compete against such strong opposition. Although the UQ team did not progress to the final rounds the moot was an invaluable experience that gave the team the opportunity to develop written and oral advocacy skills and to explore contentious and complex points of law.

The competition was hosted by Monash University in Melbourne and involved a thorough discussion of the Victorian Charter of Human Rights. The problem concerned the operation of the (now repealed) Serious Sex Offenders (Detention and Supervision) Act and the ways in which it potentially interfered with the rights enumerated under the Charter. This was an incredibly interesting and contentious area of law, and the team greatly enjoyed researching it in depth and learning about the Charter and its application.

The competition consisted of 16 teams from around Australia. The team made it to the semi-finals, where they lost to the University of Melbourne by one point. The moot was a very rewarding experience, allowing the team to moot in front of, among others, a former Federal Court judge. The feedback and experience gained will be taken by all members of the team into their future mooting and professional careers.

The Australian and New Zealand Intervarsity Moot on Animal Law (ANIMAL) is a unique competition, which focuses each year on an area of law as it applies to animals. This year's problem revolved around access to a list of private and public institutions licenced to test on animals under the Victorian Freedom of Information Act, heard in the fictional Animal Division of the Victorian Civil and Administrative Tribunal. The competition weekend, held at Griffith University Southbank Campus, involved a dozen teams from across Australia and New Zealand competing in a rapid series of rounds. For the UQ team, the weekend culminated in a semi-final against local competition Bond University, and a grand final against the University of Otago before Justices Greenwood, Burns and Boddice. Constitutional Law Moot hosted by the University of Melbourne. The moot problem this year was written by federal Solicitor-General, Stephen Donaghue, and dealt with issues surrounding the implied freedom of political communication in the context of 'fake news' and the meaning of 'court of a State' for the purposes of s 77(iii) of the Constitution. Team members were required to deal with these nuanced points of constitutional law, while also having to apply principles of statutory interpretation and court procedural rules.

The team performed at an extremely high standard during the moot, winning all four preliminary rounds and being ranked second out of 18 teams going into the knock-out rounds. Unfortunately, the team suffered defeat at the hands of the University of Western Australia, whose team went on to appear in the Grand Final of the



competition. Nonetheless, this competition successfully tested the team's research and oratory skills against those of some of the brightest law students across the country and served as exciting introduction to the world of constitutional litigation!

The Michael Kirby Contract Law Moot Competition took place this year between 24-27 September at Victoria University, Melbourne. Now in its 8th year, the competition consisted of 21 teams from 19 universities around the country.

The problem, drafted to closely resemble a real-life dispute, concerned an agreement between a mining company and an Indigenous land council, the terms of which were breached in numerous respects by both parties. The issues in dispute centred around questions of illegality, rectification, damages and debt. The team prepared lengthy written memorandums for both the Claimant and the Respondent, before presenting their oral submissions to the Tribunal in Melbourne. With the competition styled as an arbitration, the team enjoyed the opportunity to refine their advocacy skills in a different arena to the traditional moot court setting.

Faced with strong competition and creative legal arguments, the team was thrilled to progress to the quarter finals and to be awarded the prize for Best Claimant Memorandum, as well as receiving an honourable mention for the Highest Score/s in the General Rounds.

The competition was an extremely rewarding experience all round, with the team enjoying the arbitrations, befriending law students from around the country and of course, team connecting over too much of Melbourne's great (Italian) food.
