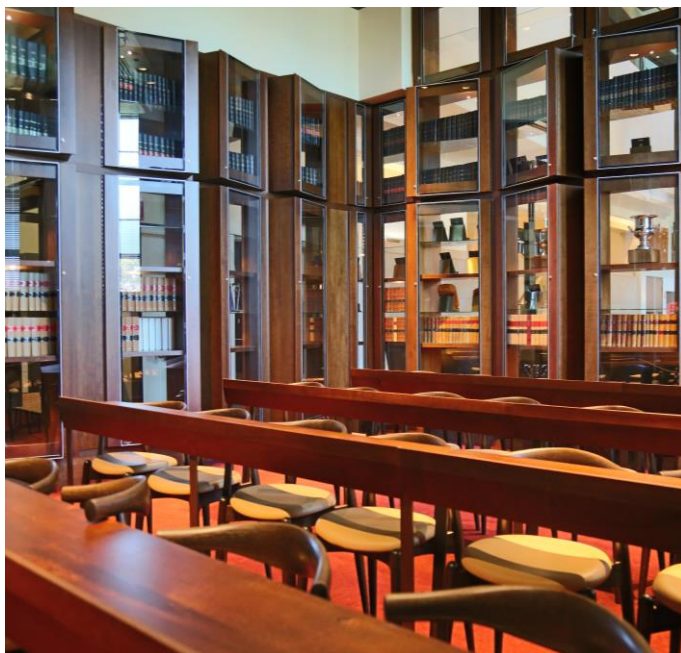

Many LLM courses are designed and delivered by renowned scholars, alumni and industry partners often working collaboratively, in order to be responsive to the needs of contemporary legal practice.

LLM seminar cohorts are small (10-40 students) enabling an intimate and personalized teaching and learning experience that inspires independent and critical thinking about the law, legal methods and the application of the law today and into the future.
